## Atlas Evaluations Terms, Scope, and Conditions

**Scope and Purpose of Evaluation:** Atlas Credential Evaluations' reports are advisory, non-binding recommendations which are intended to contextualize educational credentials earned outside of the United States of America. Our evaluations are based on the understanding that one semester credit typically equals 15 hours of classroom instruction or 30–45 hours of lab/practical work. Full-time students generally earn about 30 credits per academic year. Foreign academic credits are converted into U.S. semester credits, regardless of how many credits were originally completed. Some courses may be assigned fewer credits than expected, or none at all. The evaluation lists total recommended credits and notes courses with no U.S. credit.

Grades from international transcripts are converted to U.S. letter grades using a 4.00 scale (e.g., A = 4.00, B = 3.00, F = 0.00). Grade Point Average (GPA) is calculated by multiplying each course's grade by its credit value, totaling the quality points, and dividing by total attempted credits. All grades, including fails, incompletes, withdrawals, and pass/fail outcomes, are listed. Fails are included in the GPA. Pass grades earn credit but are not calculated into the GPA. If a course was retaken, only the first and final attempts are considered in the cumulative GPA.

**Documentation:** Evaluations of any post-secondary credential from a regionally-accredited institution are based on original, signed/stamped transcripts and diplomas received directly from the issuing institution. Evaluations of secondary-level credentials are based on scans of original signed/stamped documents provided by the client.
